Political Update

First of all, <u>thank you.</u> Thank you for supporting our work to elect conservation champions who will defend our air, water, and public lands. Because of your generosity, we were able to run the biggest MCV political program in our organization's history. This year's election was a game changer for conservation in Montana. We endorsed candidates up and down the ballot who all cared deeply about protecting clean air and water, and public lands.

Despite losing some of our races at the top of the ballot, we were still fortunate in getting I-190 and CI-118 passed, which will fund our public lands and wildlife. We also had some important endorsed local candidates win, like former MCV chair Juanita Vero, who won her race for Missoula County Commission, and Zach Brown, who won a seat on the Gallatin County Commission. Twenty-six of our endorsed candidates won seats in the State Legislature. With the 67th Montana Legislature starting in the new year, MCV will make sure to leverage all of these wins to make sure that we get policy outcomes that our climate and public lands deserve.

In the coming months, the MCV team will focus our work on the 67th session of the Montana legislature set to begin January 4, 2021. With COVID-19 still changing the way we work, the upcoming legislative session in Helena will be one of the most challenging sessions in Montana history. Governor-elect Greg Gianforte recently earned a spot on the League of Conservation Voters' "Dirty Dozen List" for his dismal record on public lands, stream access and his close ties to the oil and gas industry. Well over 800 bills have already been filed for the 90-day session but rest assured MCV will be there every step of the way fighting for our climate, our clean air and water, our public lands and our communities for future generations.
