Dear Senator Tester,

We, the undersigned Montana small business owners, write to thank you for your leadership in crafting the bipartisan infrastructure bill and supporting the budget resolution. Both of which further the bold and necessary public investments in climate smart solutions, clean energy and tens of thousands of good-paying jobs. We applaud your commitment to protect Montana's outdoor way of life and urge you to continue the fight.

As our senior Senator, you've kept your promise to do what's best for Montana. Now, you're in the unique position to continue representing those same Montana values as Congress considers crucial investments in the U.S.'s infrastructure. These critical projects can help reshape Montanans' future by addressing the climate crisis while also helping businesses drive robust economic growth throughout the state. We can and must do both.

But the money extends across all aspects of the state's economy; for every \$1 million spent in conservation activities, between 17 and 31 Montana jobs are supported. Those investments support jobs in a wide range of industries, from retail to hospitality to high tech and countless others. Protecting our outdoor spaces makes dollars and sense for our small businesses.

In a state that boasts some of the most beautiful National Parks, forests, rivers and wildlife in the world, Montanans know firsthand just how important it is to protect and conserve our outdoor spaces for future generations. It is why we and our employees choose to live here. We urge you to continue highlighting the vital role Montana's environment plays in our state. We ask you to keep up the fight and make sure Congress passes all of the necessary public investments needed to revolutionize our economy, fight climate change, drive clean energy innovations and create millions of good-paying jobs across the country.
