

## **NEWS FROM THE STATE CAPITOL**



### Marijuana Revenue Update

The fight over recreational marijuana money is coming down to two competing bills, one good and one terrible. Let's start with the good, **SB 442**. A bipartisan coalition of legislators and key stakeholders from across Montana have come together with a plan to redistribute marijuana tax revenue in a way that protects public lands, funds Habitat Montana and funds state parks and wildlife programs while simultaneously providing more resources for county roads, veterans, and other priorities. The amendments made to SB 442 now make it the best plan to distribute marijuana revenue in a way that protects and supports our public lands, rural communities, and traditional Montana values.

SB 442 just passed a second reading on the House floor with a 84-16 vote, and now it's moving on to House appropriations. It came out of the House taxation committee with a 17-4 vote following an incredible hearing last Friday with over 45 proponents from all across Montana showing up in support. SB 442 passed the Senate 49-1 before making its way to the House. We still have work to do to get it across the finish line, but with continued calls to your legislators we might see this once in a generation bill become law.

Now the bad. **HB 669** sends all marijuana tax revenue to the general fund instead of to important programs that support the Montana way of life. With enough pressure we can make sure <u>this bill never gets to the Senate floor.</u>

#### **Democracy Protections Update**

Team MCV is fighting for Democracy at the state Capitol. As the session draws to a close, we've fended off attacks on the nonpartisan judiciary and efforts to close our primaries. Here are a few bills we've opposed and defeated:

<u>SB 200</u> and <u>SB 302</u> would have injected partisanship into judicial races. Judges don't wear red or blue robes- they wear black robes. The concept of the independent judiciary is one of the bedrock principles on American Democracy and we must preserve impartiality in the courtroom.

<u>SB 484</u> would have required Montanans to register with a political party to vote in our primaries. Montanans value our independence and this bill would have limited our freedom to vote for our preferred candidate- no matter what party they represent.

The session isn't done yet though and we are still working to defeat bills in the anti-Democracy space. Keep checking <u>montanapushback.org</u> for updates and ways you can get involved.

# It's Our Right! Montanans Stand Up and Defeat the Attack on the State Constitution

Well folks, it's official-together, we DEFENDED Montana's constitution. Montana has one of the most protective constitutions in the United States when it comes to issues like our environment and public resources.

In 1972, delegates to Montana's Constitutional Convention enshrined a right to a "clean and healthful environment" in our state Constitution. For 50 years the Montana Constitution has protected our environment and public lands, and for the first time in that 50-year existence, ALL of it was at risk. However, we successfully defeated big corporations and powerful interests who were looking to exploit our public lands and resources, and we can attribute that to YOU.

## **CELEBRATING MONTANA'S MONUMENTS**

We celebrated "Montana Day" (April 6th, or "four-ohsix day" named after the state's sole area code of 406), with the release of Montana Conservation Voters Education Fund's new white paper celebrating Montana's National Monuments. In a state blessed with a wide variety of public lands, our three National Monuments- Little Bighorn, Pompeys Pillar, and Upper Missouri River Breaks-play a unique role in our communities and public land system.



The Antiquities Act, enacted in 1906, is one of our nation's most important conservation tools. Used to safeguard and protect public lands and cultural and historical sites for all Americans to enjoy. Eighteen presidents from both political parties, including most recently Presidents Biden and Trump, have designated 150 national monuments under this authority. According to a recent Colorado College poll, 82 percent of Montanans support presidents continuing to use their ability to designate existing public lands as National Monuments to maintain public access and protect the land for future generations.
