TOP TEN HIGHLIGHTS OF 2023: MCV & the MCV EDUCATION FUND

We're thrilled to share the standout moments that defined our impactful year at Team MCV! Here's a glimpse into our top highlights (listed in no particular order):

- UNITED VICTORY: Safeguarded Montanans' constitutional right to a "clean and healthful environment" by holding off malicious legislative attempts and protecting a pro-conservation majority on the Montana Supreme Court.
- 2. AMPLIFYING MONTANA'S VOICES: Team MCV helped facilitate 3,000 messages to legislators and the Governor during the 68th session of the Montana Legislature.
- 3. EMPOWERING THE PUBLIC: We published valuable public resources including MCV's 2023 Legislative Scorecard and the MCV Education Fund's first Montana National Monuments Guidebook.
- 4. HOLDING THE POWERFUL ACCOUNTABLE:
 We held Governor Greg Gianforte accountable to his veto of popular bipartisan legislation to fund our public lands, veterans' services, county roads and more through hundreds of postcards and messages from Montanans, political cartoons and billboards.
- 5. **CELEBRATING SUCCESS:** We celebrated U.S. Senator Jon Tester's federal investments in clean energy freedom and our public lands with Montanans of all stripes through our TesterGettingItDone.org campaign, distributing over 200 yard signs and a dozen billboards across the state.

- 8. DEFENDING DEMOCRACY & FAIR
 REPRESENTATION: Alongside a bipartisan group
 of Montanans and Upper Seven Law, Team MCV
 filed litigation challenging the gerrymandered Public
 Service Commission map ahead of the 2024 election.
- ELECTING PRO-CONSERVATION CANDIDATES:
 We toasted the victories of 15 pro-conservation and
 MCV-endorsed municipal candidates protecting
 pro-conservation majorities in the cities of Billings,
 Bozeman, Livingston, Missoula and Whitefish.
- **10. BUILDING POWER:** Team MCV proudly partnered with Vet Voice Foundation, Western Native Voice, Indigenous artists, and outdoor recreationists to raise up the importance of public lands and voting.

Team MCV Gears Up for 2024

With 2024 knocking on the door, Team MCV is buzzing with anticipation, gearing up for a crucial election year dedicated to advancing conservation values in Montana. We want to keep you in the loop on our endorsement process and how you can actively engage in shaping the future of our state.

RECENT ENDORSEMENTS:

In October, we proudly announced our endorsement of U.S. Senator Jon Tester for his re-election, recognizing his steadfast commitment to conservation. Additionally, just this month, we endorsed Monica Tranel, a passionate pro-conservation advocate running for the first U.S. Congressional District.

UPCOMING ENDORSEMENTS:

Momentum continues as we prepare to endorse conservation champions in several other 2024 races. From the State Legislature and the Montana Supreme Court to top statewide positions, we are committed to supporting candidates who prioritize environmental stewardship. We will endorse some candidates with proven conservation credentials starting at the beginning of the year so stay tuned.

ENDORSEMENT PROCESS:

- 1. Release of the 2024 Endorsement Memo: In mid-March, right after the candidate filing deadline, we will release our endorsement memo. This document will outline our endorsement process and provide specific questionnaires tailored to each race.
- 2. Considering Candidates: All candidate questionnaires will be reviewed by MCV's independent Political Action Committee board, the MCV Action Fund, and MCV member endorsement panels will interview candidates in contested races.
- 3. Finalizing Endorsements: By early summer, we aim to finalize all endorsements after thorough consideration of candidates' responses and alignment with conservation values. Please note, all endorsements are made by the MCV Action Fund's board.

GET INVOLVED:

- 1. Recommend a Champion: Know someone passionate about conservation running for office? We'd love to hear from you! Nominate them as a potential conservation champion.
- 2. Join an Endorsement Interview Panel: Want to play a direct role in our endorsement process? Consider serving on an MCV member endorsement panel interviewing candidates. Contact MCV's Program Director, Jocelyn Leroux (jocelyn@mtvoters.org), with your questions or interest.

LEGAL ACTION UPDATE

MCV's Fight for Democracy & Fair Representation on the PSC

Background: Earlier this fall - Montana Conservation Voters, a group of bipartisan Montanans, and Upper Seven Law filed suit to compel Secretary of State Christi Jacobson to restore a fair and competitive map for the upcoming 2024 Public Service Commission election.

Senate Bill 109, passed during the 2023 legislative session, aimed to redistrict the PSC map, consolidating one-party control through a supermajority. The resulting map, expertly analyzed, exposes its naked partisanship and discriminatory impact on voters.

Motion for Preliminary Injunction: On November 29, 2023, we filed a motion for a preliminary injunction, seeking to prevent the State from conducting the next PSC election under a gerrymandered map. This legal step is crucial in our pursuit of fair and neutral redistricting criteria, aligning with the constitutional principles that guide the Districting and Apportionment Commission for other legislative districts.

Constitutional Challenge: SB 109 faces a constitutional challenge on the grounds of discrimination against voters based on political ideas. By undermining the effectiveness of votes, it goes against the protections embedded in the Montana Constitution.

Protecting Voters' Rights: Our legal action is not just about challenging a map; it's about safeguarding the fundamental right of Montanans to fair representation. SB 109 attempts to strip voters of their decision-making power by drawing boundaries that pre-select PSC commissioners, a move that contradicts constitutional principles.

As we navigate this legal process, we will keep you updated on developments. Your support and engagement are crucial in upholding the democratic values we cherish.

The team has been hard at work hosting community events and creating education materials for their fellow Montanans. Stay tuned for events and door-knocking in your community!




An MCV Membership Makes a Great Holiday Gift!
