MCV Files Suit Challenging Gerrymandered Public Service Commission Map Ahead of 2024 Election

Last month, MCV filed suit alongside a bipartisan group of Montanans and Upper Seven Law to compel Secretary of State Christi Jacobson to restore a fair and competitive map for the upcoming 2024 Public Service Commission election.

First, what the heck is the PSC? The Public Service Commission is Montana's primary utility regulator. It has a major influence on Montana's energy policy, and the decisions made by the PSC have significant impacts on every business and home in the state. For example, the PSC just approved NorthWestern Energy's 28% rate hike for residents and small business owners.

Now why are we suing? On April 26, 2023, Governor Gianforte signed into law Senate Bill 109, which put in place a new PSC map for the 2024 election. The new map does away with decades of precedent determining Montana's PSC districts, and instead divides communities without any explanation for how the configuration represents voters' interests. The map does away with the traditional redistricting goal of preserving communities of interest and splits every major municipality in the state other than Butte as well as 14 counties, effectively guaranteeing noncompetitive elections. Stand Up for Montana's Youth

In early August, Montana's youth won a landmark climate case when a Montana District Court Judge ruled that the state of Montana has been violating the rights of the youth by not considering the impacts of greenhouse gas emissions. The ruling stated that Montana's Department of Environmental Quality (DEQ) must immediately analyze the climate impacts of new projects. However, instead of doing what it is legally obligated to do, DEQ announced a comment period to review how the Montana Environmental Policy Act (MEPA) is implemented. DEQ currently has all the information needed to analyze climate impacts so what gives? It's time to speak up and stand with Montana's youth.



To gather further information from Montanans, DEQ has held listening sessions in Billings, Helena, and Missoula. Across the state DEQ has heard a resounding call to immediately consider climate impacts, with hundreds of people turning out to tell DEQ to stop wasting time. In Missoula, Team MCV helped host a climate rally before the listening session where we heard from youth speakers about why it matters that DEQ take climate change seriously.

BCSA moved out of committee on September 21 and will be debated by the full Senate for the first time since it was first introduced in 2017. With over 60 attendees and a surprise appearance by the bill's sponsor - Senator Tester himself - the crowd heard about the importance of collaboration, protecting Montana's public lands, and making their voices heard.


