MCV held its Annual Member Celebration on March 1, drawing over 200 attendees to the Windsor Ballroom in Helena. U.S. Sen. Jon Tester, Montana Poet Laureate Chris La Tray, state legislators, local elected officials, and conservation partners from across Montana were among the guests. The event, an annual MCV tradition in Montana's capital, featured numerous sponsors at all levels and we are so grateful!

During his speech, Sen. Tester underscored the importance of MCV's mission to protect Montana's natural resources.

Save Our Smith!

At the end of February, the Montana Supreme Court reversed a lower court's decision and allowed the Department of Environmental Quality's permit for the Black Butte Copper mine to move forward. While this is a huge blow to our efforts to protect the Smith - Montana's only permitted river - there are still ways to protect this beloved river.

On March 29, the Supreme Court will be hearing arguments in a case challenging illegal water use by the mine. This lawsuit was filed by the same coalition of conservation groups that filed the previous lawsuit. If the Supreme Court rules in their favor, the mine will be unable to move forward without access to water.

Finally, we can continue to urge the Forest Service to issue a mineral withdrawal on the public lands surrounding the proposed mine. This will ensure that the mine cannot expand beyond the private land boundaries.

Want to help get MCV word out in your community?


Want to sign powerful opinion pieces, share your insights in print and radio, testify at critical legislative hearings and other official meetings, and even participate in phone banking and door knocking?
