Happy November, Montana Conservation Voters!

Last week, Team MCV scored major victories that will have a lasting impact on Montana's future. We knocked on nearly 45,000 doors, and two-thirds of our endorsed legislative candidates won — flipping 11 seats and breaking the anti-conservation supermajority in the process. One of our biggest wins came from Alanah Griffith of Big Sky, who triumphed by just over 200 votes, thanks to the tireless work of our team.

We also saw a key judicial win with Judge Katherine Bidegaray moving on to the Montana Supreme Court, where she'll continue defending our Constitution and safeguarding the moderate majority.

None of this would have been possible without your unwavering support. Your generous contributions, commitment, and engagement are the reason we were able to achieve these victories. These wins are yours, too.

Of course, it's hard not to feel disappointed by the broader results of the election. Last week, Montanans elected a full anti-conservation delegation at the federal level, and anticonservation candidates swept all five seats on the Montana Land Board — Governor, Secretary of State, Attorney General, State Auditor, and Superintendent of Public Instruction. But while these outcomes are challenging, they are part of the democratic process, and we must accept them.

What's more important now is our shared responsibility to protect what makes Montana special — our public lands, waters, air, and communities. The work ahead is critical, and we're not backing down.

At Team MCV, we are more determined than ever. We believe in the power of our government institutions and know how to leverage them — along with the power of our collective voice — to fight for the values that matter most to us.

We're moving forward, building the Montana and America we want for future generations. And we're stronger with you by our side.




