If successful, this would set a troubling precedent affecting more than 200 million acres of public land across the country, including here in Montana.


One of the biggest threats we face right now is LC 2912 — a dangerous resolution in the Montana Legislature that supports Utah's lawsuit to seize control of over 18.5 million acres of Bureau of Land Management land. This resolution also claims that federal land ownership in Montana is "unconstitutional," undermining our state's sovereignty. This is not just a political stunt — it's a direct attack on the vital public lands we rely on.

While the U.S. Supreme Court dismissed Utah's case, it can still be refiled. If Utah succeeds,

Montana's public lands could be next. This lawsuit could open the floodgates to privatizing millions of acres, including some of our most treasured places like the Missouri Breaks, the Lee Metcalf Wilderness, and the Pryor Mountain Wilderness. That's why we're delivering a petition to the 69th Montana Legislature, Governor Greg Gianforte, and Montana's U.S. Senators and Representatives on February 19, demanding them to defend our public lands.

SIGN THE PETITION But we need more than just signatures. We need you to join

us at the 2025 Rally for Public Lands on February 19 at 12 p.m. in the Capitol Rotunda in Helena. We'll be delivering the petition, standing alongside partner organizations, and sending a clear message to our elected officials: Montanans are united in our commitment to protecting access to public lands and keeping them in public hands. At the rally, hear from passionate advocates, including Hilary Hutcheson, a professional angler, guide, and award-winning



filmmaker, and Dr. Shane Doyle, an Apsáalooke historian. They'll share their powerful insights on why we must act now to protect Montana's legacy. The urgency has never been greater. Whether you're an avid outdoor enthusiast or simply someone who values our public lands, your presence matters. The 2025 Montana Legislative Session is off and running, and we've been keeping busy advocating on behalf of Montana values!

Last week, Team MCV testified in support of Senate Bill 224, which would establish Indigenous Peoples' Day as a legal holiday in Montana. This bill, brought by MCV-endorsed Senator Shane Morigeau, is a step toward recognizing and honoring Indigenous peoples in

Montana. Sign the petition and urge the committee members to VOTE YES on SB 224. Meanwhile, Montana's judiciary is being attacked on many fronts. Senate Bill 42 has passed out of committee and is now heading to the Senate floor for a vote. This bill seriously threatens the impartiality of our courts by requiring judges to identify a political party when running for office. Our courts should apply the law based on facts, not political affiliations. If

SB 42 passes, judges will face constant pressure to make decisions through a political lens, rather than delivering fair, impartial justice to all Montanans. We cannot allow partisan politics to compromise the integrity of our courts. The judiciary should remain a place where all Montanans — regardless of political background — can expect a fair and unbiased hearing. 


