It's been a whirlwind month as the Legislature enters the second half of Montana's 69th Legislative Session, with critical issues taking center stage. The good news is that any bill unrelated to revenue, appropriations, resolutions, or constitutional amendments that didn't pass one legislative chamber by the early March transmittal deadline is effectively dead. Thanks to the efforts of folks like you, we've seen some harmful bills fall by the wayside. Unfortunately, several misguided and problematic proposals are still in play and could threaten our freedoms and the values that make Montana the Last Best Place.

But Montanans aren't backing down. Thousands of you have already raised their voices through <u>MontanaPushback.org</u>. This winter, we rallied for public lands and our state Constitution, braving winter storms, challenging roads, and flu season. We also had a fantastic time at MCV's Annual Member Celebration in Helena.

Now, we need to keep that momentum going. There's still work to be done to defeat the harmful ideas that remain in the Legislature, including serious threats to our constitutional right to healthy public lands, clean water, and clean air, as well as critical funding for our public lands, state parks, trails, and wildlife. It's time to speak up. Make your voice heard with the Governor and your legislators — let them know where you stand!

And lastly, some personal news. Since joining the team in 2018, it has truly been an honor to work alongside our talented staff and dedicated boards to protect what makes Montana, *Montana*. Looking back, I'm humbled by the impact this organization has made and proud of all we have accomplished together. After much thought, I've decided the time has come for me to move on.

Standing Up for Montana's Public Lands

A huge thank you to everyone who joined us at the 2025 Rally for Public Lands in Helena. Your support is a powerful reminder of Montanans' unwavering commitment to protecting our public lands. Together, we are sending a strong message that Montana's public lands are not for sale and must remain in public hands.

On February 19, we gathered at the Capitol Rotunda, where over 1,000 passionate Montanans stood united to defend the places we love — places where we hunt, fish, hike, and camp. At the rally, we delivered over 1,000 petition signatures to Governor Greg Gianforte, the Montana State Legislature, and Montana's Congressional delegation, urging them to reject efforts to privatize our public lands and oppose Utah's lawsuit seeking control of federal lands.

Your presence at the rally, along with the overwhelming support shown through the petition, has made a powerful statement. Montanans have spoken loud and clear: Our public lands are not for sale, and we will fight to keep them accessible for future generations.

But the fight is not over. **LC 2912**, a joint resolution sponsored by Representative Tom Millett, supports Utah's lawsuit, which poses a direct threat to over eight million acres of Montana's public lands, including some of our most cherished places, such as the Missouri Breaks, Lee Metcalf Wilderness, and Pryor Mountain Wilderness. With your help, we can make it clear to our elected officials that Montanans won't stand by while our lands are at risk.

As we move forward, your continued support is essential in keeping this fight alive. Our public lands are not just beautiful landscapes; they are integral to Montana's economy, culture, and way of life. Your voice — whether at the rally, through petitions, or in future actions — will help ensure these lands remain protected.

Thank you again for using your voice. Together, we are stronger. We are more than just a group of individuals we are a community united in our love for Montana's public lands.

Senate Bill 42 has passed the Senate and is now set to be heard in the House Judiciary Committee after transmittal break. This bill would require both Montana District Court and Montana Supreme Court judges to identify a political party when running for judicial positions. This would introduce unnecessary partisanship into a system that should be focused solely on the law and facts free from political influence and biased justice.
